Award Criteria

Individuals/organizations receiving this recognition will have made a significant contribution, within the past two years, in advancing the contaminated sites field. Nominees (either individually or as a group) should demonstrate a high level of personal involvement and have demonstrated exceptional leadership in the contaminated sites community of practice and in public involvement/outreach.

Judging Criteria

Nominations will be scored based on the following criteria:

- **Leadership** (worth 40% of the final score)
Have the nominee/group's efforts clearly demonstrated vision, foresight and determination?
- **Advancement within the contaminated site field** (worth 25% of final score)
Have the nominee/group's project/initiative/work led to improvements in the field and/or contributed to accomplishments by others?
- **Effectiveness** (worth 25% of the final score)
What were the nominee/group's goals? How do they measure against the success?
- **Innovation, creativity and originality** (worth 10% of final score)
Were the nominee/group's efforts, methods, strategies and/or ideas innovative?

Entry Requirements

- Completed nomination form.
- Names, titles, and responsibilities of those involved in the project.
- Project documentation as per attached form.
- **Deadline for submission: March 15, 2008**

Award

A plaque with a commemorative inscription will be presented to the winner(s) at the 2008 RPIC Federal Contaminated Sites National Workshop, and announced on the RPIC website.

Scores will be attributed using the following:

- Do the nominee/group's efforts clearly demonstrate leadership in the field?
- Were the nominee/group's activities proactive?
- Have the nominee/group's activities promoted public awareness and understanding and shown active concern and leadership for the enhancement and protection of the environment particularly in the contaminated site field (if so, please describe)?
- Was the nominee/group instrumental in identifying, reducing, and solving contaminated sites issues, and advancing the contaminated sites field?
- Do the benefits of the actions extend beyond the nominee/group, contribute to the contaminated site community at large, and possibly lend itself to replication by others doing similar work?
- Has the nominee/group's actions resulted from, created or enhanced existing partnerships (if so, please describe)?
- What objectives/goals were established for this activity, and how were the results measured?
- What specific objectives/ goals were met, and have they resulted in net benefit to the contaminated site field?
- What were the nominee/group's activities/ approach to a particular contamination problem or challenge facing a particular geographical area (local, regional, state-wide, national, a city, a community) or a specific area of contamination?
- Does the project/work demonstrate the use of practices that exemplify outstanding creativity/innovation or introduce new approaches?
- Do nominee/group's efforts clearly demonstrate the use of practices that go beyond standard techniques or regulatory standards?

Nomination forms must address the following five areas in a maximum of 1,500 words.

- **Brief overview of the work/project**
- **Leadership**
Have the nominee/group's efforts clearly demonstrated vision, foresight and determination?
- **Advancement within the contaminated site field**
Have the nominee/group's project/initiative/work led to improvements in the field and/or contributed to accomplishments by others?
- **Effectiveness**
What were the nominee/group's goals? How do they measure against the success?
- **Innovation, creativity and originality**
Were the nominee/group's efforts, innovative methods, strategies and/or ideas?
